Liability Waiver

The Student (hereinafter, a minor) participating in or attending classes at Donna Tucci's School of Dance, Inc., the undersigned, being the student and the parents or legal guardian of the student, do hereby, for ourselves, our heirs, assigns, executors and administrators, covenant not to sue, remise, release and forever discharge Donna Tucci's School of Dance Inc., a Florida Corporation, whose address is 10245 Southern Blvd., Royal Palm Beach, FL 33411 (hereinafter, its premises) its agents, employees, independent contractors, officers, and trustees (hereinafter, the School of Dance) and further agree to indemnify and hold Donna Tucci's School of Dance Inc. harmless from and against any claim, demand, cause of action, suit, liability, damage, judgment, levy, or execution (hereinafter collectively, claims) including any attorneys' fees and court costs incurred by Donna Tucci's School of Dance Inc., in prosecuting any such suit, action, claim, or counterclaim, arising out of the death or injury of a student or the loss or destruction of any personal property of the student while present at Donna Tucci's School of Dance Inc., at any residence provided by Donna Tucci's School of Dance Inc., or any other location in connection with the student's participation in any program, class, or activity offered by the School of Dance, whether or not caused, in whole or in part, by Donna Tucci's School of Dance Inc., its agents, employees, independent contractors, officers, trustees, or representative's negligence, omissions or otherwise.

In further consideration of the student participating or attending the classes at Donna Tucci's School of Dance Inc., the undersigned hereby agree that we will not institute, prosecute, or in any manner whatsoever, aid in the institution or prosecution of any claim, demand, cause of action or suit against the school of Dance.

Treatment Authorization

Further, the undersigned hereby authorizes Donna Tucci's School of Dance Inc. to make arrangements for and obtain any type of emergency medical treatment whatsoever for the student, which in the School of Dance's sole opinion, is or may be necessary or appropriate for the student. The undersigned hereby releases the School of Dance from agrees to indemnify and hold Donna Tucci's School of Dance Inc. harmless from and against any claims, damages, suits, costs, or expenses incurred relative to any emergency medical treatment provided to the student or arranged for the student's benefit by the School of Dance.
